## **WHAT IS THE INVESTMENT CONTRACT FOR NATIVE CONTRACT PROJECTS WITH EXTRACTDAO S.A.?**

Investing in a native ExtractoDAO contract is designed for small, large, and medium-sized investors with the goal of generating profits through the sale of asset fractions to the global retail market. This is a unique concept, as it represents the first time since the emergence of timeshare in the 1950s in France that global sales can be executed securely on the blockchain.

It's worth noting that the ExtractoDAO team already possesses experience in property development, and the project creators have a traditional background in real estate construction. Now, with a platform that enables substantial profits from timeshare fractions, an opportunity arises for the market to participate, not only in timeshare but also in the cattle futures market where we have existing operations. Thus, we are not presenting an idea to investors but rather a reality that does not currently exist in the cryptocurrency market—a DeFi platform with a DEX capable of operating in the physical products market.

Additionally, for third-party contracts listed on the ExtractoDAO platform, only operation and intermediation fees will be charged. We will not act as custodians for these clients, and the responsibility for these contracts lies entirely with the companies, producers, and startups that list their futures contracts on the DEX.

We have designed an investment model in native contracts that do not take place directly on the platform. In this model, we engage with investors, investment funds, and entrepreneurs seeking a safe and more conservative approach to real estate development, such as timeshare. Investors share profits with ExtractoDAO based on the results of retail sales of fractions. For example, with Sweet Place, we can achieve profits of up to 615%, considering that current prices are still below regional market rates. In the same region, a seven-day stay in comparable accommodations can cost up to \$2,000 per week. Fraction buyers enjoy a 60-year consecutive usage right or can lock the contract in the DeFi platform to receive profits in USDT, USDC, DAI, or BUSD. These profits are then deposited into the liquidity pool for retail investors who choose to rent these fractions.

We also offer a native contract for cattle feedlot investments. However, this contract is exclusively available to professional investors with more than \$1,000,000 in consideration that this market yields lower returns of around 15% to 25% annually, given the nature of the agriculture sector.
